Applications are invited online for the **PG (Kaychikitsa (MD) (Ay) Management quota 01 seat** in the college from candidate who have passed BAMS with minimum 50% as well as qualified in the AIPGET (2020-21). Applicants shall furnish scanned copies of their AIPGET Score Card, BAMS Degree Certificate, TCMC Registration Certificate, Mark Lists, Plus Two Mark sheet and SSLC Book with the application.

Last date of receipt of applications online shall be **5 pm on 02.02.2021**. Rank list will be published on our website and notice board on **03.02.2021** and the eligible candidates for admission to Management Quota Seat as per the said norms will be intimated over Land Phone/Mobile Phone/e-mail as the case may be.

**Admission to the available seat will be made from 07.02.2021 to 11.02.2021.**

**The Tuition Fee is Rs. 5,25,000/- annually for three years and the Special Fee 1st year Rs. 91,300/-\* and @ Rs. 72,500/-\*, annually for the next two years.**

6. Physical Fitness Certificate.
7. Candidate who have passed their qualifying examination from Universities / Boards outside the state shall produce an "Eligibility Certificate" from the concerned University in Kerala, to the effect that the qualifying examination has been recognized by the university.
8. The student who qualifies from other universities should produce migration Certificate at the time of admission.
9. Originals of all the uploaded documents/certificates (to prove nativity/reservation/fee concession).

## **ASC 100/20/MD/MS AYURVEDA/KISMA**

MD/MS Ayurveda Admission 2020-21- Approval of draft prospectus for admitting 15% Management quota seats in respect of the Kerala State Indian System of Medicine Self Financing College Management Association (KISMA)- Order issued 18.01.2021.

### **PRESENT**

Hon'ble Mr. Justice R Rajendra Babu - Chairman

### **READ**

1. Lr. No. KISMA/ARC/001/210 dated 04.01.2020 from the President, Kerala State Indian System of Medicine Self Financing College Management Association (KISMA)
2. G.O (Rt) No. 480/2020/Ayush dated 31.12.2020 issued by the Ayush Department, Government of Kerala.

### **ORDER**

1. The President, Kerala State Indian System of Medicine Self Financing College Management Association, in short the KISMA, through communication dated 04.01.2020 has submitted the draft prospectus for admitting 15% Management quota seats for the MD/MS Ayurveda courses for the academic year 2020-21 along with the Government order dated 31.12.2020 for permitting 15% seats under Management quota to be filled up by the management.
6. The Committee scrutinised the prospectus submitted by the KISMA and found that there are Five (5) member colleges under KISMA for MD/MS Courses for the academic year 2020-21. The member Ayurveda Medical Colleges have submitted the letter of permission and affiliation order from

the competent authorities. Therefore, the Committee hereby provisionally approve the prospectus submitted by the KISMA with the following directions and observations.

- i.** The application shall be invited by the Association/ Member Colleges only through online. No other mode of inviting application shall be entertained and liable to be rejected.
- ii.** The online application should contain the following information:-
  - The online application form should contain Auto generated Registration/ Application Number and auto generate date and time of submission of application.
  - The facility for uploading the photograph and signature of the candidate shall be provided.
  - The category/quota shall be clearly specified in the online application form. The category once selected shall not be changed under any circumstances.
  - The declaration of the candidate, as to the details provided in the application are true to the best of knowledge, should be included in the online application form.
  - The facility for taking print out of the application shall be provided to the candidate by the Ayurveda Medical College.

The President of KISMA/ the Principal of the member colleges shall ensure that the aforesaid information is included in the online application form.

- iii.** The President of the KISMA is hereby directed to submit the draft

notification for inviting online application for admitting 15% Management quota before the committee **on or before 22.01.2021**, for approval. The approved notification shall only be published in the dailies and the electronic media.

- iv** The member colleges come under the KISMA shall not be entitled to retain the certificates of 1<sup>st</sup> year fee, if the student discontinues the course before the last date of closing of admission, prescribed by the competent authorities.
- v.** The collection of liquidated damages shall be as per the final decision of the ASC/Court of Law. The colleges have no right to retain the Certificate and TC in case of student leaving the college, and the same shall be released, on the student with one of his/her Parents executing a bond undertaking to obey the order that may be passed by the Committee or the Court of Law.
- vi** The President of KISMA is hereby directed to obtain prior approval from the committee at every stage of admission procedure.
- vii** The President, KISMA has submitted the modified admission schedule before the committee for approval. The Committee scrutinised the same and found that the admission schedule required certain changes as stated below. The admission schedule is hereby approved with the changes made by the committee
