Online applications, in the format specified, are invited for admission in the 7 (Seven) vacant Management Seats for UG (BAMS) Course at PNNM Ayurveda Medical College from candidates who have passed Plus II with minimum 50% marks in Physics, Chemistry and Biology put together and minimum 50% marks in Biology separately as well as qualified in the NEET and KEAM (2020-2021).

Before filling the application form the applicant must read the directions mentioned below from the Admission Supervisory Committee dated 10.02.2021 regarding the Management admission.

Applicants shall submit scanned copies of their Age Proof (SSLC Certificate), Plus II mark sheet, Plus II Pass certificate, NEET Score Card, KEAM Data Sheet, Transfer Certificate and Conduct Certificate from the previous institution, Caste Certificate, Income Certificate, Migration and Physical Fitness Certificate along with the application. Last date of receipt of applications online shall be 5 pm on 19-02-2021. The list of applicants will be published in our Website and Notice Board on 19-02-2021 (after 6 pm). The Rank List of the eligible candidates for admission to Management Seats as per the said norms will be published in our website on 22-02-2021 and will be intimated to the eligible candidates over phone/mobile/e-mail, as the case may be. Admissions to the available Management Seats will be made from 23-02-2021 to 25-02-2021. The **Tuition Fee is Rs. 1,99,415/-** annually, for five years and the **Special Fee for 1st year is Rs. 83,406/-**, the **next four years @ Rs. 59,244/-**, annually and **Caution Deposit Rs. 10,000/-**.
