## ADMISSION NOTIFICATION BAMS - MANAGEMENT: 2020-2021

Online applications, in the format specified, are invited for admission in the 9 (Nine) vacant Management Seats for UG (BAMS) Course at PNNM Ayurveda Medical College from candidates who have passed Plus II with minimum 50% marks in Physics, Chemistry and Biology put together and minimum 50% marks in Biology separately as well as qualified in the NEET (2020-2021).

**Before filling the application form the applicant must read the directions mentioned below from the Admission Supervisory Committee dated 19.03.2021 regarding the Management admission-Vacant Seat.**

Applicants shall submit scanned copies of their Age Proof (SSLC Certificate), Plus II mark sheet, Plus II Pass certificate, NEET Score Card, Transfer Certificate and Conduct Certificate from the previous institution, Caste Certificate, Income Certificate, Migration and Physical Fitness Certificate along with the application. Last date of receipt of applications online shall be 5 pm on 25-03-2021. The Rank List of the eligible candidates for admission to Management Seats as per the said norms will be published in our website on 26-03-2021 and will be intimated to the eligible candidates over phone/mobile/e-mail, as the case may be. Admissions to the available Management Seats will be made from 26-03-2021 to 29-03-2021. The **Tuition Fee is Rs. 1,99,415/-** annually, for five years and the **Special Fee for 1st year is Rs. 83,406/-**, the **next four years @ Rs. 59,244/-**, annually and **Caution Deposit Rs. 10,000/-**.

BAMS/MD/MS Ayurveda Admission 2020-21- Request submitted by the President KISMA and the Member Colleges come under the KISMA for filling up of the Management vacant seats and the Government Stray vacancies- - Order issued on 19.03.2021.

### **ORDER**

1. The president KISMA through communication dated 18.03.2021 has reported that some seats are lying vacant in the Ayurveda medical Colleges come under the KISMA under Government lapsed seats for BAMS/ MD/ MS Ayurveda courses for the academic year 2020-21. The President, KISMA has also submitted that the list prepared by the CEE is exhausted. Therefore, they have requested to permit them to admit NEET qualified candidates who have not registered in the KEAM website.
2. The Committee has gone through the submission made by the President, KISMA and through communication dated 18.03.2021 has requested the Commissioner for Entrance Examinations to clarify whether the Ayurveda rank list prepared by the CEE is exhausted or not.

3. The CEE through communication dated 18.03.2021 has clarified that the CEE has directed the KISMA member colleges to fill up the stray vacancy from the list prepared by the CEE up to 20.03.2021. If any vacancy still lying vacant necessary action may be initiated to fill up the vacant seats.
4. Some of the Ayurveda Medical Colleges have also requested for permission to conduct spot admission to fill up the vacant seats. But since the CCIM has extended the closing date of admission up to 31.03.2021, as per the communication dated 19.03.2021, the permission for conducting the spot admission is not allowed for the time being.
5. In the above fact situation, the Committee hereby direct the member colleges come under the KISMA to invite the fresh online application to fill up the vacant seats for Government stray vacancies and Management quota vacant seats for BAMS/MD/MS Ayurveda Courses for the academic year 2020-21.
