ADMISSION NOTIFICATION - BAMS

Online applications, in the format, specified, are invited for admission in the 9 (Nine) NRI Seats for UG (BAMS) Course at PNNM Ayurveda Medical College from candidates who have passed Plus 2 with minimum 50% marks in Physics, Chemistry and Biology put together and minimum 50% marks in Biology separately as well as qualified in the NEET (2021-22). Applicants shall furnish scanned copies of their NEET Score Card, Plus 2 mark sheet and Pass certificate & Age Proof (SSLC Certificate) along with the application. The candidates also shall submit the Original Transfer Certificate and Conduct Certificate from the previous institution where the candidate was admitted.

Copies of the Passport, Visa and undertaking of the NRI, sponsoring the applicant, along with the Certificate from the Village Officer in support of the relation of the Sponsor with the applicant as specified and as per the directives issued by AFRC in compliance of the Honourable High Court Order that the sponsor shall declare that the student is dependent on the sponsor for the course of study. The Candidate shall produce the sworn affidavit from the Sponsor in a stamp paper worth Rs. 200/-. The same shall also be notarised by the Notary Public, disclosing that the student is dependent of the sponsor and the all expenses i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the Sponsor.

Before filling the application form the applicant must read the directions mentioned below from the Admission Supervisory Committee dated 29.01.2022 and 14.02.2022 regarding the NRI admission.

Issue of application form begins from **18-02-2022** and the last date of submission of applications online will be on **03-03-2022 at 5.00 pm**. The provisional list of applicants will be published in our Website and Notice Board on **04-03-2022 (after 5 pm)**. Filing the complaints if any **05.03.2022**. Last date of correction of entry errors, if any, by the candidate **06.03.2022, 05.00 pm**. The Rank List of the eligible candidates for admission to NRI Seats as per the said norms will be published on our website on **07-03-2022** and will be intimated to the eligible candidates over phone/mobile/e-mail, as the case may be. Admissions to the available NRI Seats will be made from **08-03-2022 to 11-03-2022**. The Tuition Fee is **Rs. 3,00,000/-** annually, for five years and the Special Fee for 1st year, is **Rs. 83,406/-** and the next four years @ **Rs. 59,244/-**, annually. The Special Fee notified above relates to the academic year 2021-22, which may be revised, as and when decided by the AFRC, in due course.

ORDER

1. The Government of Kerala has promulgated Kerala Medical Education (Regulation and Control of Admission to Private Medical Educational Institutions) Act 2017, in short the Act, and constituted the Fee Regulatory Committee, herein after referred as the Committee. The Committee is empowered to regulate the tuition fee, special fee, Hostel fee and to prevent the collection of capitation fee for admission to Medical Institutions in

Kerala, as per the said Act 15 of 2017.

2. The Hon'ble High Court through various judgements have directed the Institutions to submit the proposal of tuition fee with relevant documents well in advance to regulate the tuition fee for every year. The Hon'ble Court also directed to furnish any information that is required for the purpose of arriving at a decision that the fee proposed by the institutions is neither excessive nor exploitative in nature.
3. But the Ayurveda/ Siddha/ Unani Medical Colleges have not so far submitted documents for regulating the tuition fee for the academic year 2021-22, in the due time as per the above direction of the Hon'ble High Court.
4. Thereafter, the President, Kerala State Indian System of Medicine Self Financing College Management Association (KISMA) through communication dated 14.01.2022 submitted a representation before the Committee relating to the regulation of tuition fee, which would read as below:

“The Tuition fee and Special Fee for the UC and PG Courses in the Self-financing Ayurveda, Siddha and Unani Colleges in Kerala were fixed for the Academic Year 2019- 2020, vide the references cited. The member colleges of the KISMA Association did not raise any demand for revision of the tuition fee and Special fee during 2020-21, in view of the Pandemic (COVID 19) outburst in the state and the world as well. The situation being continued still, we, the member colleges of the KISMA Association do not make any demand for revision of the Tuition Fee and Special fee during 2021 22 also. Therefore, we hereby agree to continue the same rate of Tuition Fee and Special Fee during the Academic Year 2021-22 also.”

5. The representation of the President, KISMA has been placed before the

committee for consideration. Accordingly, the committee considered the matter and has decided to accept the submission of the President, KISMA. Considering the representation of the KISMA, the Committee decided to fix the same tuition fee, as fixed by the Committee for the academic year 2020-21 in respect of BAMS/BUMS/BSMS/MD/MS Ayurveda Courses to the academic year 2021-22 also. The tuition fee for BAMS Course was fixed at Rs. 1,99,415/- per annum the tuition fee for BSMS/ BUMS Courses were fixed at Rs.1,89,000 /-and for NRI fee in respect of the BAMS/BSMS/BUMS Courses are @ Rs. 3,00,000/- and the special fee for BAMS/BSMS/BUMS course are Rs. 83,406/- for the 1st year and remaining years Rs. 59,244/- respectively for the academic year 2020-21. The fee for MD/MS Ayurveda Courses were fixed @ Rs. 5,25,000/- for clinical courses & 2,63,000/- for non-clinical courses and special fee in respect of MD/MS Courses @ Rs. 96,300 for 1st year and Rs. 76,495 for remaining years for the academic year 2020-21.

6. The Committee has also observed that the Director of the Vishnu Ayurveda Medical College, Shoranur, Palakkad through various communications have undertaken that they shall accept the fee fixed for the other Ayurveda (KISMA) colleges from the academic year 2017-18 onwards. Therefore, the Committee decided to fix the same fee, which was fixed in other Ayurveda colleges, for Vishnu Ayurveda Medical College for the academic year 2021-22 for BAMS Course.
7. The Principals of the Ayurveda/Siddha/Unani Medical Colleges are hereby permitted to collect the Tuition fee, NRI fee and Special fee, as mentioned in the Annexure I & II for the academic year 2021-22 for BAMS/BSMS/BUMS/MD/MS Ayurveda Courses. The institute cannot charge either directly or indirectly any other amount over and above the amount fixed as tuition fees/special fee.

8. The order is passed as a single common order for all the PG & UG Ayurveda/Siddha/Unani Medical Colleges. The details of the tuition fee and special fee of the respective colleges as mentioned in the Annexure I & Annexure II attached to this order.

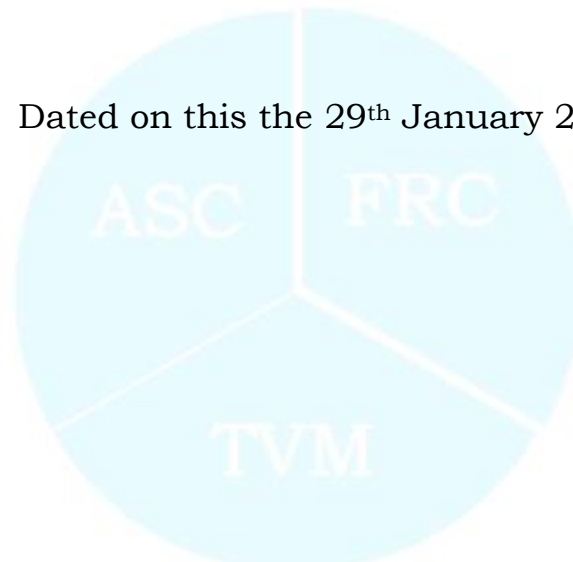

MD/MS/BAMS/BUMS/BSMS Admission 2021-22- Approval of draft prospectus for admitting 15% NRI quota seats in respect of the Kerala State Indian System of Medicine Self Financing College Management Association (KISMA)- Order issued 14.02.2022.

1. Lr. No. KISMA/ASC/2021-22 dated 24.11.2021 from the President, Kerala State Indian System of Medicine Self Financing College Management Association (KISMA), received in this office on 29.11.2021
2. G.O (Rt) No.456/2021/AYUSH dated 18.11.2021 issued by the Ayush Department, Government of Kerala
3. Order No. FRC 50/21/MD/MS/BAMS/BUMS/BSMS/SFAMC dated 29.01.2022

ORDER

1. The President, Kerala State Indian System of Medicine Self Financing College Management Association, in short the KISMA, through communication dated 24.11.2021 has submitted the draft prospectus for admitting 15% NRI quota seats in respect of the Ayurveda, Siddha, Unani, courses and PG Courses for the academic year 2021-22.
2. In the meanwhile, the Government has issued an order dated 18.11.2021, wherein it is stated that self-financing institutions coming under the Ayush Department can admit 15% seat under NRI quota provided affiliation has been obtained from the KUHS and CCIM.

3. The Committee scrutinised the prospectus submitted by the KISMA and found that there are Thirteen (13) member colleges under KISMA for BAMS/BUMS/BSMS Courses, out of which Five (5) Member Colleges are having PG Courses also for the academic year 2021-22. On scrutiny of the documents submitted by the KISMA, it is found that the member colleges have neither submitted the letter of permission obtained from the CCIM nor the affiliation order obtained from the KUHS, except Mannam Ayurveda Medical College, Sree Narayana Institute of Ayurvedic Studies, Pankajakasthuri Ayurveda Medical College and Santhigiri Siddha Medical College. However, the Committee hereby provisionally approve the prospectus submitted by the KISMA with the following directions and observations.

- i.** The President of KISMA should inform the member colleges that the prospectus approval order will not be applicable to the member colleges which have not submitted the letter of permission from the CCIM or provisional affiliation order from KUHS within one week from the date of receipt of the order.
- ii.** The application shall be invited by the Association/ Member Colleges only through online. No other mode of inviting application shall be entertained and liable to be rejected.
- iii.** The online application should contain the following information:-
 - The online application form should contain Auto generated Registration/ Application Number and auto generate date and time of submission of application.
 - The facility for uploading the photograph and signature of the candidate shall be provided.
 - The category/quota shall be clearly specified in the online

application form. The category once selected shall not be changed under any circumstances.

- The declaration of the candidate, as to the details provided in the application are true to the best of knowledge, should be included in the online application form.
- The Directions issued by the Committee on various dates regarding the NRI admission should be published in the Association/ College website.
- The facility for taking print out of the application shall be provided to the candidate by the Ayurveda Medical College.

The President of KISMA/ the Principal of the member colleges shall ensure that the aforesaid information's are included in the online application form of the member colleges.

- iii.** The Admission to the NRI quota shall strictly be as per the GO (Ms) No. 243/14/H&FWD dated 06.08.2014 and the directives issued by the Committee on various dates. The NRI candidates should qualify in the NEET Entrance Examination.
- iv.** The President of the KISMA is hereby directed to submit the draft notification for inviting online application for admitting 15% NRI quota before the committee **on or before 16.02.2022**, for approval. The approved notification shall only be published in the dailies and the electronic media.
- v.** The member colleges come under the KISMA shall not be entitled to retain the certificates and 1st year fee, if the student discontinues the course before the last date of closing of admission, prescribed by the competent authorities.

- vi.** The collection of liquidated damages shall be as per the final decision of the ASC/Court of Law. The colleges have no right to retain the Certificate and TC in case of student leaving the college, and the same shall be released, on the student and one of his/her Parents executing a bond undertaking to obey the order that may be passed by the Committee or the Court of Law.
- vii.** The President of KISMA is hereby directed to obtain prior approval from the committee at every stage of admission procedure.
- viii.** The Principals of the member colleges are hereby permitted to collect the tuition fee and special fee for NRI candidates allowed by the Committee, as per the FRC 50/21/MD/MS/BAMS/BUMS /BSMS/SFAMC dated 29.01.2022
- ix.** Considering the Present pandemic situation, the Committee hereby given a provisional academic schedule for inviting online application and filling up the 15% NRI seats for MD/MS and UG Ayurveda, Siddha, Unani Courses for the academic years 2021-22. If any changes required in the academic schedule, the KISMA shall obtain the prior permission from the ASC.
