Applications are invited online for the PG (Prasuti Tantra Evum Stri Roga (MS) (Ay) Management quota 01 seat in the college from candidate who have passed BAMS with minimum 50% as well as qualified in the AIPGET (2022-23). Applicants shall furnish scanned copies of their AIPGET Score Card, BAMS Degree Certificate, TCMC Registration Certificate, Mark Lists, Plus Two Mark sheet and SSLC Book with the application.

Issue of application form begins from 29-01-2023 and the last date of submission of applications online will be on 04-02-2023 at 5.00 pm. The provisional list of applicants will be published in our Website and Notice Board on 04-02-2023 (after 5 pm). Filing the complaints if any 04.02.2023. Last date of correction of entry errors, if any, by the candidate 06.02.2023, 05.00 pm. The Rank List of the eligible candidates for admission to Management Seats as per the said norms will be published on our website on 07-02-2023 and will be intimated to the eligible candidates over phone/mobile/e-mail, as the case may be. Admissions to the available Seat will be made from 07-02-2023 to 10-02-2023.

The Tuition Fee is Rs. 5,25,000/- annually for three years and the Special Fee 1st year Rs. 96,330/-* and @ Rs. 76,495/-*, annually for the next two years.

<u>ORDER</u>

- The Government of Kerala by order dated 16.11.2022 has permitted the selffinancing medical colleges which come under Ayush department to fill up 15 % N.R.I/Management quota seats from the approved annual intake, observing the guidelines/criteria fixed by the Admission Supervisory Committee, hereinafter referred to as the Committee.
- 2. In due compliance of the above direction, the President, Kerala State Indian

System of Medicine Self Financing College Management Association (KISMA) has submitted a draft prospectus before this Committee for taking 15% admission under management quota seats of the member colleges that come under the KISMA, for approval.

3. On preliminary verification of the draft prospectus, it is found that 6 Medical Colleges are having MD/MS (Ayurveda) Courses under KISMA and they have included the seat matrix for management quota in the draft prospectus. Details of the seat matrix are given hereunder.

- 4. On detailed scrutiny, it is also found that the member colleges of KISMA who are conducting the MD/MS Ayurveda Courses have submitted the affiliation orders obtained from the National Commission for Indian System of Medicine (NCISM) as well as the Kerala University of Health Sciences (KUHS) for conducting the PG Ayurveda courses for the academic year 2022-23.
- 5. The Committee, having scrutinised the draft prospectus and the notification submitted by the KISMA, hereby provisionally approve the same subject to observations and directions given below.
 - (i) The President of KISMA shall publish the approved notification for inviting online applications in the electronic media and dailies. No other notification except the one approved shall be published in the dailies.
 - (ii) Applications shall be invited by the Member Colleges through online only. No other mode of inviting application shall be entertained.
 - (iii) The online application should contain the following information:-
 - The online application form should contain auto generated Registration/ Application Number and auto generated date and time of submission of application.
 - The facility for uploading the photograph and signature of the candidate shall be provided.
 - ♦ The category/quota shall be clearly specified in the online



application form.

- The declaration of the candidate stating that the details furnished in the application are true to the best of knowledge of the applicants shall be included in the online application form.
- Facility for taking print outs of the application shall be provided to the candidate by the Medical College.
- (iv) The member colleges of KISMA shall not be entitled to retain the first year tuition and other fees, if the student discontinues the course before the last date of closing of admission prescribed by the competent authorities. Students who discontinue to course shall be given their original qualifying certificates and the transfer certificate, on request by them.
- (v) President of the KISMA has included the tentative schedule of MD/MS (Ayurveda) courses in the prospectus. Committee has gone through the tentative schedule suggested by the KISMA as well as the cut-off date prescribed by the NCISM. After considering the said document, the Committee hereby prescribe the tentative admission schedule for taking 15% management quota for MD/MS Ayurveda courses for the academic year 2022-2023. If any changes are required in the dates prescribed by the Committee, the Principal shall obtain prior permission.

- (vi) On behalf of the member colleges, the President of KISMA has submitted a representation together with the draft prospectus stating that the tuition fee and special fee in respect of MD/MS courses for the academic year 2021-22 were fixed by the Fee Regulatory Committee and that they agree to continue the same rate of tuition fee and special fee during the academic year 2022-23 without any hike.
- (vii) Considering the representation, the Committee hereby permit the

member colleges which come under the KISMA to collect the same rate of tuition fee and special fee fixed by the FRC during the previous academic year, for this academic year (2022-23) also. Names of the member colleges and details of the tuition fee and special fee for the academic year are given in Annexure I.

- (viii) Principals of the member colleges shall collect from the students of MD/MS coursesthe approved tuition fee and special fees only. The member colleges cannot charge either directly or indirectly any other amount over and above the amount fixed as fee. If any other amount is charged, under any other head or guise, that institution shall be liable to face penal action as directed in the judgments of the Apex Court as also the provisions of Act 15 of 2017.
- (ix) Principals of the member colleges are directed to collect the approved tuition fee and special fee only through online payment/ cheque/DD/RTGS/IMPS from the candidates of MD/MS Ayurveda courses for the academic year 2022-23 onwards.
- (x) The President, KISMA is hereby directed to include the details of the tuition fee and the special fee, as given in Annexure I to this approval order, in the prospectus for the academic year 2022-23.

- (xi) In various orders of the Hon'ble Supreme Court, self-financing colleges are restrained from illegally procuring bonds from the students. The principals of the member colleges shall not obtain bonds from the students without prior permission from the competent authorities.
- (xii) The member colleges of KISMA are directed to obtain prior approval from the Committee at every stage of the admission procedure.
- (xiii) The President of KISMA is directed to submit the modified prospectus before the Committee after making the above corrections at the earliest. The modified prospectus alone shall be uploaded in the College website.
