Online applications, in the format specified, are invited for admission in the 08 (Eight) vacant Management Seats for UG (BAMS) Course at PNNM Ayurveda Medical College from candidates who have passed Plus II with minimum 50% marks in Physics, Chemistry and Biology put together and minimum 50% marks in Biology separately as well as qualified in the NEET (2023-2024).

**Before filling the application form the applicant must read the directions mentioned below from the Admission Supervisory Committee dated 05.10.2023 regarding the Management admission.**

Applicants shall submit scanned copies of their Age Proof (SSLC Certificate), Plus II mark sheet, Plus II Pass certificate, NEET Score Card, Transfer Certificate and Conduct Certificate from the previous institution, Caste Certificate, Income Certificate, Migration and Physical Fitness Certificate along with the application. Last date of receipt of applications online shall be **17-10-2023**. The list of applicants will be published in our Website and Notice Board on **18-10-2023**. Filing the complaints if any **19.10.2023**. Last date of correction of entry errors, if any, by the candidate **20.10.2023, 05.00 pm**. The Rank List of the eligible candidates for admission to Management Seats as per the said norms will be published on our website on **21.10.2023** and will be intimated to the eligible candidates over phone/mobile/e-mail, as the case may be. Admissions to the available Management Seats will be made from **21.10.2023 to 26.10.2023**.

The Tuition Fee is **Rs. 1,99,415/-** annually, for five years and the Special Fee for 1st year is **Rs. 83,406/-**, the next four years @ **Rs. 59,244/-**, annually and Caution Deposit **Rs. 10,000/-**.

## **ORDER**

1. The Government of Kerala by order dated 19.08.2023 has permitted the self-financing medical colleges which come under the Ayush Department to fill up 15 % N.R.I seats from the approved annual intake, observing the guidelines/criteria fixed by the Admission Supervisory Committee, hereinafter referred to as the Committee.
  
2. In due compliance of the above direction, the President, Kerala State Indian System of Medicine Self Financing College Management Association (KISMA) has submitted before this Committee for approval, a draft prospectus for taking 15% admission under N.R.I quota seats of member colleges that come under the KISMA.
  
3. On preliminary verification of the draft prospectus, it is found that there are 13 member colleges conducting UG/PG Ayurveda, Siddha and Unani (ASU) courses under the KISMA. The Principals of the member colleges have submitted the affiliation orders obtained from the National Commission for Indian System of Medicine (NCISM) as well as Kerala University of Health Sciences (KUHS) for conducting the UG/PG ASU courses for the academic year 2023-24.
  
5. The Committee scrutinised the draft prospectus as well as the notification submitted by the KISMA. Committee hereby provisionally approves the

prospectus and the notification subject to observations and directions given below:

- (i) The President of KISMA is directed to publish the approved notification for inviting online applications in the electronic media and dailies. No other notification except the one approved shall be published in the dailies.
- (ii) Applications shall be invited by the member colleges through online only. No other mode of inviting application shall be entertained.
- (iii) The online application should contain the following information:-
  - ❖ The online application form should contain auto generated registration/ application number and auto generated date and time of submission of application.
  - ❖ The facility for uploading the photograph and the signature of the candidate shall be provided.
  - ❖ The category/quota shall be clearly specified in the online application form.
  - ❖ The declaration of the candidate stating that the details furnished in the application are true to the best of knowledge of the applicant shall be included in the online application form.
  - ❖ Facility for taking print outs of the application shall be provided to the candidate by the Medical College.

- (iv) The member colleges of KISMA shall not be entitled to retain the first year tuition and other fees, if the student discontinues the course before the last date of closing of admission as stipulated by the competent authorities. Students who discontinue the course shall be given back their qualifying certificates and transfer certificate immediately on request made by them.
- (v) President of KISMA has included the tentative schedule of UG/PG ASU courses in the prospectus. Committee has gone through the tentative schedule suggested by KISMA as well as the cut-off date prescribed by NCISM. After considering the above documents, the Committee hereby prescribe a tentative admission schedule for taking 15% N.R.I quota for UG/PG ASU courses for the academic year 2023-24. If any change is required in the dates prescribed by the Committee, the Principal shall obtain prior permission from the Committee.

- 6.** On behalf of the member colleges, the President of KISMA submitted a representation before the Committee on 05.07.2023 stating that they do not want to hike the existing tuition fees and other fees for this academic year also i.e. 2023-24. Accordingly, KISMA has requested the Committee to approve the existing tuition fees and other fees of UG/PG ASU courses (i.e. 2022-23) for the academic year 2023-24 also.
- 7.** Committee considered the representation in the meeting of the Committee held on 19.07.2023 and decided to permit the member colleges that come under KISMA to collect for this academic year, i.e. 2023-24 also the same rate tuition fee and special fee as was fixed by the FRC in the previous academic year. Ordered accordingly.
- 8.** Names of the member colleges and details of the tuition fee and special fee of under graduate and post graduate ASU Courses for the academic year

2023-24 are given in Annexure I & II respectively.

- 9.** Principals of the member colleges shall collect the approved tuition fee and special fees only from the students of UG/PG ASU courses. The member colleges shall not charge either directly or indirectly any other amount over and above the amount fixed as fee by FRC. If any other amount is charged, under any other head or guise, action of the management will be treated as collection of capitation fee and the same will invite penal action as provided in the judgment of the Apex Court and the provisions of Act 15 of 2017.
- 9.** Principals of the member colleges are directed to collect from the students of UG/PG ASU courses, the approved tuition fee and special fee through online payment/ cheque/DD/RTGS/IMPS only.
- 10.** The President, KISMA is hereby directed to include the details of the tuition fee and the special fee, as given in Annexure I & II to this approval order, in the prospectus for the academic year 2023-24.
- 11.** The Hon'ble Supreme Court has passed orders restraining the private college management from procuring bonds from students. Principals of the member colleges are hereby prohibited from collecting bonds from the students without the permission of the competent authorities.

12. The member colleges of KISMA are hereby directed to obtain prior approval from the Committee at every stage of the admission process.
13. President of KISMA is directed to submit the modified prospectus before the Committee after making the above corrections, at the earliest. The modified prospectus alone shall be uploaded in the College website.
14. Email this order to the President, KISMA and the Principals of the member colleges under the KISMA.



**ORDER**

1. Admission Supervisory Committee, hereinafter referred to as the Committee, by order dated 12.09.2023 has provisionally approved the draft prospectus submitted by the Kerala State Indian System of Medicine Self Financing College Management Association, for short, KISMA, for taking 15% admissions under NRI quota seats in respect of the member colleges that come under the KISMA for Ayurveda/Siddha/ Unani (ASU) courses 2022-23.

2. The President of KISMA vide letter dated 25.09.2023 reported the

Committee that even after the completion of the admission procedures permitted by this Committee, many seats are lying vacant in the ASU Medical Colleges under the KISMA. The details of the vacancies in each member college have been furnished. The President of KISMA has requested the Committee to permit the member colleges to convert the vacant N.R.I seats to Management seats and fill those vacancies.

3. The Principals of the member Medical Colleges have also submitted a detailed report together with the joining and non-joining list before the Committee.
4. The Committee has gone through the report and supporting documents submitted by the ASU member Medical Colleges as also the President of KISMA and finds that some seats are lying vacant in some of the ASU member Medical Colleges, as per the details given hereunder.
